Chairman's Message



am happy to report that IIM Ranchi has completed another successful year, and we could celebrate our 3rd Foundation day.

The PGDM programme continued to be our primary educational effort, and at the Convocation held on the 4th of March 2013, 66 students, who had successfully completed their studies, were awarded diplomas. We had also started a PGPEX programme and 59 diplomas were awarded to the successful candidates at the Convocation. Dr. Xavier continued to be the Director of the Institute during the year, and the progress made by us was due to the mentorship from the IIM Calcutta, and the hard work and commitment of the Director and the staff of the institute. Like all new IIMs, it is not easy to find suitable faculty for all the courses that the institute conducts, and we have had to take

recourse to faculty from reputed global institutes in the US, UK and the Philippines. I believe that this approach has value and exposes our students to international practices and experiences.

Our curriculum offers courses on Indian Culture, Inner Development, Analytics and Neuro Management.

Efforts continued to be made during the year to get land from the State Government for the construction of the permanent campus. However, due to various reasons, suitable land could not be acquired and transferred to us during the financial year. We are hopeful that this problem would get resolved soon.

The Board of Governors continued to meet regularly and guided and directed the activities of the Institute. Prof. Vikas Srivastava joined the Board in December 2012 as a representative of the faculty. I am personally indebted to the Board for their support and help in the management of the Institute.

The Institute recognized the need for interacting with industry and business so that their inputs could help us better design the courses to meet the needs of the actual users. A programme (PGDHRM) for this has been put in place.

The products of the IIM Ranchi are accepted by industry and business to be of high quality.

Before ending I must place on record the contribution made by the employees of IIM Ranchi, without which we could not have got so far. The Ministry of Human Resource Development has, as always, been a great source of strength and guidance to us. I am sure with the cooperation of all concerned IIM Ranchi will continue to progress rapidly.

Director's Message



t is my pleasure to present the Third Annual Report - a time to reflect on our accomplishments over the past year, as well as encompassing its growth in the last three years. IIM Ranchi has come a long way from the time it started functioning in 2010. Today we have an infrastructure with modern facilities for class rooms, library, offices and finest hostel facilities.

IIM Ranchi is a leading provider of education, offering a comprehensive range of programmes and services with a commitment to excellence in learning.

It entered into its third year and admitted 117 students in the 3rd batch of PGDM. Within a short span of time we have introduced two new programmes. From June 2012 the Institute started Fellow Programme in Management (FPM), equivalent to a doctoral

programme and a two year full time Post Graduate Diploma in Human Resource Management (PGDHRM). In the 1st batch of FPM, five students were admitted to make a career in their area of choice. In the first batch of two year full-time PGDHRM programme 44 students took admission. The curriculum for PGDHRM is designed in consultation with NHRDN.

To grow its faculty strength, 10 faculty members were appointed in various areas in the past one year. Our teachers continue to embrace innovative teaching and learning strategies by taking advantage of many professional development opportunities.

A two-day International Conference on Management in the New World Order was conducted on August 13 & 14, 2012. Apart from this, the Second HR Conclave and a Leadership Summit was organized during the year. We have also conducted number of training programmes for the executives of State Government officials and have taken up some prestigious consultancy assignments for the Department in the State Government as well as for the Government of India.

IIM Ranchi continued its initiative of bringing the best minds of the corporate world and academics to interact with the students and to broaden their horizon. Aiming to bring corporate leaders from diverse fields on a common platform where students can interact with them and gain valuable insights on their domain of expertise, the 2nd Colloquium-2012 was inaugurated in July and was opened till December. The testimony of IIM Ranchi's standing is also evidenced by its 100% placement record. The students have received offers from national and international companies, with competitive compensation packages.

Through our collective work and commitment to our distinctive intellectual and educational environment, we renew our pledge to develop the Institute every day. However, creating and renewing this environment also requires continuous attention to infrastructure and facilities that support faculty and student work. None of this would be possible without the vision and generosity of the Board of Governors, support from Government of Jharkhand, our faculty and staff, whose assistance has made a key contribution to the Institute's momentum.

The Institute



The ninth Indian Institute of Management was established at Ranchi in 2010. This was made possible with the extensive support of the Indian Institute of Management Calcutta and the Government of Jharkhand, working under the guidance of Ministry of HRD, Government of India.

We started at a time when the management education world over was criticized for over emphasis on competition, aggression and achievement of results by any means. American model of education has come under criticism from various quarters. Additionally

Educational technologies have removed the aura and exclusivity of top ranking b-schools by making it possible to take quality education beyond the citadels of management (coursera, edex, khans academy etc.).

We realized the need for a major surgery of the curriculum as there was a disconnect between what was taught and what was needed by the business and the society. We understood the need to incorporate right values in the young minds and also impart education relevant for information age that encourages networking and collaborative advantage. Also we decided to build contextual knowledge into the programs.

IIM Ranchi currently offers two year Post Graduate Diploma in Management (PGDM) and Post Graduate Diploma in Human Resource Management (PGDHRM) as its flagship programmes. From 2012 it started offering Fellow Programme in Management (FPM) for doctoral education. It also offers an 18 month Post Graduate Programme in Management for Working Executives (PGPEX).

To be among the top 10 Management Institutes in the Asian Region within the next 10 years through innovative curriculum and technology enabled delivery methods. (Within 2 years, we have been ranked the best among the new IIMs and the fourth best in the Eastern region)*.

The academic block consists of six aesthetically designed classrooms equipped with computers, projectors, modern sound systems, OHPs and other audio-visual tools. The entire academic block including the library is equipped with Wi-Fi connectivity.-



Library



The IIM Ranchi library is known as "Athenaeum-The Learning Resource Center". It has a mixed collection of both print and electronic format, which include books, journals, databases, CDs/DVDs, e-journals, reports, etc. The Learning Resource Center plays a very important role in providing information service for the academic community in their intellectual pursuits.

The library provides a wide variety of services to the users both in-house and network based services. The electronic resources subscribed by the library are accessible to the users

through Institute's network. The library's functions and services are fully automated. The users can access the online library catalogue and find out the availability of library materials from their own computers.

Information Technology

The Information Technology tools take care of the computing and communication needs of IIM Ranchi.

Five Rack Mounting servers and Three Blade Servers with necessary accessories host a variety of services including IIM Ranchi's website. Two Cyberoam UTM, one at Academic Block and the other at Hostel handles Intrusion Detection and Prevention, Content and Application Filtering, besides managing Antivirus, Anti-spyware, and Gateway Anti-spam etc. All servers have Microsoft Windows Server license and Red Hat Linux enterprise license. Every computer in the library has Windows operating system and is equipped with antivirus.

The network backbone is designed with Single Mode Fiber Optics cable and the internal network is equipped with Cisco 3750 Switch and Cisco 2960 Access Switches. The academic block is internally connected through Wi-Fi as well as wired LAN (10 Mbps 1:1 internet bandwidth provided by RailTel) to support round the clock: access to the resources on the network.

The remotely located hostel is connected to the academic block through a Virtual Private Network (VPN). The hostel area also has 24x7 network access through Wi-Fi as well as wired LAN (20 Mbps 1: 1 internet bandwidth provided by RailTel). Both the academic block and the hostel area use Cisco Aironet 1242 series, Ubi quiti UniFi Outdoor Access Points and Dlink DWL-3200 secured Wi-Fi connectivity.

IIM Ranchi has also become part of the National Knowledge Network (NKN) a state-of-the-art pan-India network: implemented by the National Informatics Center (NIC). The NKN provides 1 Gbps connectivity out of which 100 Mbps is allocated for Internet bandwidth and the rest for Intranet bandwidth to provide inter-university and NKN pool connectivity.

Hostel

The Student Block of IIM Ranchi, situated in the residential area of the sports village, is located in Khelgaon, around 12 kilometers from the academic block at Suchana Bhawan, Ranchi. There are rooms for accommodating the students in Khelgaon.

The housing facility consists of a mix of three bedroom and four bedroom shared flats that are fully furnished. The mess and a canteen, and a dispensary for medical concerns remain open for nearly 20



hours a day on an average. All the rooms in the flats have single occupancy and are installed with campus LAN and Wi-Fi connectivity for accessing internet. House-keeping services are also provided.

Each block has two guards looking over 24x7 and nobody other than students, faculty and other employees of the institute are allowed to enter.

The facility consists of separate stadiums for sports like basketball, tennis, badminton, swimming, athletics etc. on membership basis.

IIM Ranchi has a unique portfolio of faculty model that accommodates a mix of accomplished core faculty and visiting faculty. The core faculty members of IIM Ranchi, comparable with the best in the country, teach one-third to half of the courses. The remaining courses are taught by visiting faculty from the Industry and other leading Institutions from India and abroad. The proposed faculty mix helps the students gain strong theoretical background and also get exposed to practical applications and developments in the industry and Institutions around the world.


Admission Criteria





Fellow Programme in Management (FPM)

Introduction

The Fellow Programme in Management (FPM) is the doctoral programme of IIM Ranchi. This programme has the objective of developing outstanding scholars for teaching or research careers at business schools/universities or management research institutions or careers in Government, industry, NGOs or for that matter any organization that requires advanced analytical and research capabilities. To accomplish this, the institute will seek to admit students who have a strong academic background, are highly motivated and who have the intellectual curiosity to undertake original research and provide them with knowledge and research skills that can make them specialized researchers with sufficient depth of knowledge in the various existing and emerging management knowledge domains.

Students generally take four years, including two years of rigorous course work, to complete their doctorate. The first year of the course work is common with IIM Ranchi Post Graduate Programme and is aimed at providing a participant with a broad understanding of the field of management. The second year of the course work is to ensure that candidates have deep understanding of their knowledge domain and a developed ability to do rigorous research in their chosen area of specialization. The Area Comprehensive Examination at the end of the second year is designed to assess whether the candidate has acquired requisite level of proficiency in his/her area of specialization. In the subsequent years, the candidate works on the doctoral dissertation which is expected to be an original contribution in the area of management.

Students admitted to the programme receive comprehensive financial support that covers all academic and living costs. The Institute has excellent library, computing and faculty resources. Provision is also there for some of the candidates to work under the guidance of reputed international faculty.

Post Graduate Diploma in Management (PGDM)

Curriculum

1st Term

The PGDM is a two year full-time programme, consisting of six trimesters with a compulsory summer internship at a prestigious organization. The curriculum has been designed keeping in view the changing needs of the organizations in global scenario and taking into consideration the following aspects:

- □ While the hard elements (analytic tools) may be universally applicable, the soft elements (values, attitudes etc.) need to be culture specific.
- A manager should have a broader understanding of the context in which businesses operate.
- □ With the power-shift to the east, particularly India and China, we have a great opportunity to develop models that are likely to have Universal value.
- □ Align courses with the institute's vision of holistic development and erudite fusion to attain thought leadership.

During the first year (1st, 2nd & 3rd terms), students are exposed to/taught core courses consisting of 53 total credits in the areas of Marketing, Finance, Quantitative Methods, Operations, Organizational Behaviour and Strategy as they lay foundation for all major functional areas of management . In the 2nd year (4th, 5th & 6th terms) they need to complete 3 core courses and some non-credit compulsory courses. The students also need to choose from a wide range of elective courses for specializing in functional areas. If any student would like to do dual specialization, he/ she may also do so. Total credits needed to graduate are 120 to 126.

Post Graduate Programme in Management for Executives (PGPEX)





Activities

Management Development Programmes (MDPs)

Fundamental of Project Management Professional

ndian Institute of Management, Ranchi in association with the University of Houston conducted a programme on "Fundamental of Project Management Professional (PMP)" on July 20 and 21, 2012. This programme was all about streamlining a project/work in



a structured way to make sure it is completed on time and under budget. The objective of this course was to help prepare participants for PMP exam as well as introduce them to the Energy Management.

The program was conducted by Dr. Binay Anand from University of Houston in a lively atmosphere and all sixty four participants enjoyed thoroughly. TATA Steel, TELCO and CIL wanted this program to be conducted for their employees also and IIM has assured them to conduct it again next year.

Finance for Medical Professionals



The Programme was coordinated by Prof. Vikas Srivastava and Prof. N. Sivasankaran.

IIM-Ranchi conducted a 5-day Management Development Programme on **"Finance for Medical Professionals"** from August 31 to September 5, 2012. The program was designed to give medical professionals inputs and core concepts in the areas of accounting, costing, investment and financial decision making besides hospital administration and management. These inputs gave the medical professionals a framework for better decision making keeping financial aspects in mind.

15 reputed medical professionals including Director, Rajendra Institute of Medical Science, Ranchi; Director, Alam Hospital, Ranchi and other organizations such as CCL, Rani Hospital, Shri Jagannath Hospital, AVT, etc. attended the MDP.

2nd Programme on Finance for Medical Professionals

IM Ranchi conducted a two-day program "Finance for Medical Professionals" on Dec.15 & 16, 2012 at the institute premises. In his inaugural address, Prof M.J. Xavier, Director insisted the participants to apply the knowledge gained through this programme in their hospital such that they become a model hospital in the region. In his inaugural speech, he has quoted the examples of Aravind Eye Hospital and Narayan Hirudalaya for success in managing health care in India. The participants of this MDP included Doctors, Administrators and Medical Directors



of various hospitals functioning in and around Ranchi. This is the second time the institute conducted MDP on the topic for the healthcare sector. The uniqueness of this programme is that it had participants from the private sector hospitals. The programme offered inputs to the participants to assess their profitability and liquidity requirements besides knowing the costing insights of their operations. Further, the decision makers of the hospitals were given insights on how to evaluate their capital expenditure decisions and how to maximize the returns from their investments.

The hospitals that took part in the programme include Aalam Hospital, Nagri Hospital, Chen Dental Clinic, Gulmohar Hospital, Dr Ruban Hospital (Patna), Park Hospital (Patna) and Jeevak Hospital (Patna). The participants felt that the programme has enabled them to manage the financial aspects of their hospitals. The programme was co-ordinated by Prof.Vikas Srivastava, Prof Anand & Prof N. Sivasankaran. Mr. B. Jagan Rao, the Administrative Officer under the guidance of Col. Bala K. Nair, Vice President (Admin) of the institute has provided the administrative support for the conduct of this programme.

Consultancy

Business Valuation for NALCO

The consultancy project titled "Business Valuation for NALCO" taken up on behalf of MECON Ltd has been successfully completed.

Survey Relating to the Plying of Auto-Rickshaws in the City of Ranchi

The Transport Department of Government of Jharkhand has assigned a project to IIM-Ranchi relating to the "Plying of Auto-rickshaws in the City of Ranchi".

The study is directed towards the detailed survey in the Ranchi city on the following issues:

- □ What numbers of auto rickshaws are plying at present in the city of Ranchi?
- □ What is the approximate number of passenger trips which the auto rickshaws are undertaking every day?
- □ What number of auto rickshaws will be required to meet the present needs of the city of Ranchi?

The study was conducted by a team comprising of Dr. M. J. Xavier, Dr. Subir Verma and Dr. Amit Sachan and they used the qualitative and quantitative research methods including:

- □ Secondary data obtained from government sources/documents, policies, regulations, guidelines and Government Orders related to the social aspects of the project.
- □ Field visits and interaction with stakeholders at different levels.
- □ Semi-structured interviews of the auto rickshaws drivers.

Recruitment of Junior Engineers and Assistant Engineers for JSRRDA

A team consisting of **Dr M J Xavier, Dr Amit Sachan and Dr Tanusree Dutta** has conducted recruitment process of Junior Engineers (JEs) & Assistant Engineers (AEs) for Jharkhand State Rural Road Development Authority (JSRRDA). For a total no. of 50 AE posts and 150 JE posts, 1195 (386 for AEs & 809 for JEs) applications were received, which were scrutinized and were found suitable for the written test. After the Written Test, 157 candidates for AE post and 384 for JE post were interviewed. Finally, a list of 50 AEs and 150 JEs was sent to JSRRDA for recruitment.

Assessing the status and Performance of Rural Drinking Water Supply Sector

The Department of Drinking Water & Sanitation, Government of Jharkhand assigned a project titled "Assessment of Rural Water Sector for State of Jharkhand". A team consisting of Dr M J Xavier, Dr Subir Verma and Dr Amit Sachan was set up to asses the programme status and the performance of the rural drinking water supply schemes in the state. The team also provided the inputs for the design of the project and its implementation.

Foundation Day

IIM Ranchi celebrated its third foundation day on July 6, 2012 at Hotel BNR Chanakya. The function was marked by the presence of Mr. A. M. Misra, Vice President, Coke, Sinter & Iron and Industrial Relations, Tata Steel Ltd., Jamshedpur as the honorable Chief Guest and Mr. R P Singh, Advisor to MD, Tata Steel Ltd, Jamshedpur as the Guest of Honor.

Prof M J Xavier gave the welcome Address which spelt out the objectives and aspirations of the institute as the fastest

About Ranchi


City of Traditions
